## Florida State Action

### October 9

#### [District Court sides with state on school reopening order](#)

The First District Court of Appeals overturned the Leon County Circuit Court's decision on Commissioner Corcoran's emergency order, in which it had declared the July school reopening order unconstitutional.

### September 30

#### [Governor extends local government meetings order](#)

Executive Order 20-246 extends EO 20-69, relating to the ability for local government to meet virtually during the pandemic. The order is effective immediately and expires on November 1<sup>st</sup>.

### September 25

#### [Governor orders state into Phase 3 of Reopening](#)

Governor DeSantis issued Executive Order 20-244 which moves the state into Phase 3 of Reopening and lifts all remaining state-level restrictions on businesses as a result of the coronavirus pandemic. Additionally, the order prevents cities and counties from closing businesses or collecting fines from pandemic-related mandates, such as mask requirements.

### September 18

#### [Governor Ron DeSantis Announces Disbursement Plan for Second Round of CARES Act Funding to Counties](#)

Governor DeSantis announced the State of Florida's plan for the second round of disbursement of the Coronavirus Aid, Relief, and Economic Security (CARES) Act funding for counties with populations below 500,000. This second round of funding provides an additional \$255 million, for a total of \$574 million, to these 55 counties.

Emergency Order 2020-10 by the Department of Business and Professional Regulation (DBPR) rescinds previous EO 2020-09 which ordered bars to shut down. Effective Monday, 9/14, bars may reopen at 50% occupancy.

### September 8

#### [Florida to start paying Federal Lost Wages Assistance benefits](#)

Today, Governor Ron DeSantis announced Florida has been approved to provide and has processed three weeks of LWA program benefits to eligible Floridians. This means the Florida Department of Economic Opportunity (DEO) is providing an additional \$300 per week to eligible Reemployment Assistance claimants.

#### [State adopts task force recommendations on nursing home reopening](#)

Emergency Order 20-009 by the Florida Division of Emergency Management lifts restrictions for visitation to nursing homes, assisted living facilities (ALFs), adult family-care homes, adult group homes and other long-term care facilities.

### September 1

#### [Governor extends deadline for Bright Futures scholarship](#)

Executive Order 20-212 extends the deadline for students graduating in the 2019-20 school year to earn the minimum qualifying SAT or ACT score to earn a Bright Futures scholarship until December 1, 2020.

### August 31

#### [Governor extends limited version of mortgage foreclosure and eviction relief order](#)

Executive Order 20-211 provides a limited, one-month extension to Executive Order 20-180, which made significant changes to prior versions of the mortgage foreclosure and eviction relief orders.

### August 28

#### [Governor suspends DBPR alcohol licensing deadlines through 2020](#)

Executive Order 20-210 suspends all renewal deadlines for licenses, registrations, permits, or certificates overseen by the Department of Business and Professional Regulation's Division of Alcoholic Beverages and Tobacco regarding the manufacturing, sale, or distribution of alcohol. The order is in effect through December 31<sup>st</sup>.

### August 26

#### [Governor Announces Florida's Participation in the Federal Lost Wages Assistance Program](#)

The Lost Wages Assistance (LWA) Program provides additional temporary benefits for individuals who are eligible for Reemployment Assistance for weeks of unemployment ending on or after Aug. 1, 2020. Pending federal approval, this will allow Florida to offer an additional \$300 per week to eligible Reemployment Assistance claimants.

Today, Governor Ron DeSantis announced the formation of Florida's Task Force on the Safe and Limited Re-Opening of Long-Term Care Facilities. Members of the task force will work together to develop guidelines on how to safely allow family members to visit their loved ones in Florida's long-term care facilities where visitation has been prohibited since March due to the COVID-19 pandemic.

### [Governors amends restaurant employee screening protocols](#)

Executive Order 20-192 amends Executive Orders 20-68, 20-139, and 20-166, directing the Department of Business and Professional Regulation (DBPR) to require restaurants to follow CDC guidelines on employee screening protocols. Additionally, the order lifts travel restrictions, including the 14 day quarantine, for residents or visitors coming from New York and other high-risk areas.

## July 22

Executive Order 20-95 directs the Florida Department of Revenue to issue an emergency order suspending the collection of doc stamp taxes for moneys businesses receive under the CARES Act SBA loan program, known as the Paycheck Protection Program.

Executive Order 20-94 suspends statutes providing for a mortgage foreclosure cause of action and eviction cause of action for 45 days.

**[Governor orders state agency workers to help DEO with reemployment assistance](#)**

Executive Order 20-93 directs agencies to have all available state personnel temporarily assist the Department of Economic Opportunity (DEO), to make alternate application formats available, and to immediately procure the necessary services to address problems with the current reemployment assistance program known as CONNECT.

## March 27

### [Governor prohibits vacation rentals, implements checkpoints for travelers](#)

Executive Order 20-87 suspends any new reservations for vacation rentals for the next 14 days.

Executive Order 20-85 directs DMS to amend state employee health plan benefits to include telehealth services at no additional cost and to waive costs for influenza vaccinations, effective immediately.

### March 24

#### [Governor directs Surgeon General to issue public health advisories](#)

Executive Order 20-83 directs Surgeon General Rivkees to issue public health advisories to those 65 and older or anyone who has underlying medical conditions, warning of the dangers of gathering in groups of 10 or more, and asking people to work from home when feasible.

#### [Governor expands on New York area quarantine requirement](#)

Executive Order 20-82 adds anyone who is covered by this order must inform anyone they have contact with in the last 21 days of their travel to prevent community spread.

### March 23

#### [Governor orders 14 day quarantine for all New York area travelers](#)

Executive Order 20-80 requires any air travelers to Florida from the New York tri-state area (New York, New Jersey, Connecticut) must be screened upon arrival and quarantined for 14 days.

### March 20

#### [Governor orders prohibition on elective and non-emergency surgeries](#)

Executive Order 20-72 directs physicians and healthcare professionals to stop performing any medically unnecessary, non-urgent or non-emergency procedures which, if delayed, would not harm patients.

On March 13, 2020, President Trump declared the rapidly evolving COVID-19 situation a national emergency. This bold action enables the Centers for Medicare and Medicaid Services (CMS) to waive certain requirements in Medicare, Medicaid, and CHIP under Section 1135 authority. This includes the ability to grant state and territorial Medicaid agencies a wider range of flexibilities, and states may now submit Section 1135 waiver requests for CMS approval that will remove administrative burdens and expand access to needed services. Shortly after the President's declaration, Florida became the first state to submit a Section 1135 waiver request in response to the COVID-19 national emergency.

Emergency Order 20-02 indicates that libraries are already closed as of March 19<sup>th</sup> and requires all parks to close and certain social distancing changes to go into effect for public transportation as of March 24<sup>th</sup>.

### **Alachua County issues shelter-in-place and closure of non-essential businesses**

Emergency Order 20-09 requires that all non-essential business and operations must cease. All places of public assembly are closed to the public. People should not leave their homes except for essential activity.

### **Jacksonville asks businesses to allow employees to work from home**

Emergency Order 2020-3 asks businesses to allow their employees to work from home, if at all possible. This goes into effect Tuesday morning, March 24<sup>th</sup> at 8am.

## **March 22**

### **Broward County closes all non-essential businesses**

Emergency Order 20-01 directs all non-essential retail and commercial business to close down, effective March 23<sup>rd</sup>. This does not apply to healthcare providers and public health operations, grocery stores, banks, transportation operations, childcare centers, and more.

### **Palm Beach County orders all marinas, boat ramps closed**
